

GET MARRIED DREAM HONEYMOON VIDEO CONTEST

OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS CONTEST. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

HOW IT WORKS: Entrant (individually, the “**Entrant**,” and collectively, the “**Entrants**”) will submit a Video Entry (as hereinafter defined) to Get Married, LLC (the “**Sponsor**”) during the Contest Entry Period (as hereinafter defined) which describes why the Eligible Couple (as hereinafter defined) designated in the Video Entry consists of a “prince” and “princess” who are most deserving of winning the “Get Married Dream Honeymoon Video Contest” (the “**Contest**”). From those Video Entries submitted during the Contest Entry Period, Sponsor will then designate, at its sole and absolute discretion, certain Entry finalists (individually, a “**Finalist**,” and collectively, the “**Finalists**”) whose Video Entries will then be posted on www.getmarried.com (the “**Get Married Website**”) for voting by registered members of getmarried.com (“**Registered Members**”). There is no fee to become a Registered Member. Subject to the terms of these Contest Official Rules (the “**Official Rules**”), the Finalist receiving the highest number of eligible Registered Member votes by the conclusion of the Online Voting Period (as hereinafter defined) will be deemed the winning Entry, with the Eligible Couple designated in such Entry being awarded the “Get Married Dream Honeymoon Video Contest” Grand Prize. In the event of a tie vote, the Sponsor, in its sole and absolute discretion, will determine the winning Video Entry and the Grand Prize winner. Only the Eligible Couple will be awarded the Grand Prize under the terms of these Official Rules, with no other party being eligible for any other prize, including, without limitation, the Entrant, unless the Entrant is a member of the Eligible Couple.

WHO MAY ENTER THE CONTEST: An Entrant must be a Registered Member and otherwise meet the following eligibility requirements to submit a Video Entry and enter the Contest. If the Entrant is not already a Registered Member, then the Entrant may follow the instructions designated on the Get Married Website to become a Registered Member. An Entrant may be a member of the Eligible Couple or any other individual(s) that satisfies the requirements of these Official Rules. The Contest is open only to legal residents of the fifty (50) United States and District of Columbia, who as of the date of their entry into the Contest are eighteen (18) years of age or older. Employees of Sponsor, its prize suppliers, Disney Destinations, and each of the foregoing entities' affiliates, and other Sponsor-authorized designees associated with the design, administration and/or fulfillment of the Contest (collectively, the “**Contest Entities**”), as well as members of such employees' immediate families (spouses, children, siblings, parents) or households (whether or not related), are not eligible to participate in the Contest. The Contest is void outside the specific area stated above and where prohibited or restricted by law.

HOW TO ENTER THE CONTEST: An Entrant may submit a Video Entry and enter the Contest either online, or via delivery using the U.S. Mail, UPS, Federal Express, or other delivery service. To enter online (“**Online Entry**”), an Entrant must follow all of the instructions for online submission designated on the Get Married Website, including, without limitation, the instructions for registering for the Contest and the uploading of the Video Entry. To enter the Contest by U.S. Mail, UPS, Federal Express, or other delivery

service (“**Mail-In Entry**”), an Entrant will be required to send to Get Married Dream Honeymoon Video Contest, 3453 Holcomb Bridge Rd, Norcross, Georgia 30092, a Video Entry, in either DVD or VHS format, along with a postcard, upon which will be hand printed the following: (i) Entrant’s first and last name, street address (no P.O. boxes), city, state, zip code, daytime telephone number (including area code), date of birth, gender, e-mail address, and Registered Member name, (ii) the first names, last names, and ages of the bride and groom forming the Eligible Couple, along with the Eligible Couple’s street address (no P.O boxes), city, state, zip code, daytime telephone number (including area code), e-mail address, and Registered Member name (either bride or groom), and (iii) the title and a brief description of the Video Entry. Online Entries and Mail-In Entries are herein singularly referred to as an “**Entry**,” and collectively referred to as the “**Entries**”. **ONLY ONE (1) CONTEST ENTRY PER PERSON AND/OR E-MAIL ADDRESS WILL BE ACCEPTED. ANY ATTEMPTED ENTRIES IN EXCESS OF THAT LIMIT SHALL BE DEEMED VOID.**

VIDEO ENTRY: Along with each Entry, each Entrant shall submit, either as an Online Entry or a Mail-In Entry, an approximately two (2) minute video (the “**Video Entry**”) explaining why the couple (the “**Eligible Couple**”) depicted or otherwise promoted in the Video Entry consists of a “prince” and “princess” who are most deserving of winning the “Get Married Dream Honeymoon Video Contest” Grand Prize. Eligible Couples must be Registered Members, must have been married, or must be engaged to be married, between September 12, 2007, and September 12, 2009, and otherwise meet all of the other eligibility requirements applicable to the Entrants. Sponsor may, in its sole discretion, post any one or more of the Entry Videos in a “video gallery” on the Get Married Website for viewing by the public. With respect to each submitted Video Entry, the submitting Entrant, the Eligible Couple, any other individuals appearing in the Video Entry, the videographer and such other persons involved with the production of the Video Entry (if such persons are a third party other than the Entrant or other individuals appearing in the Video Entry), understand, acknowledge and agree that Sponsor is under no obligation whatsoever to post any Entry Video on the Get Married Website or to continue to display on the Get Married Website any Video Entry previously posted, and/or otherwise to use the Video Entry as permitted pursuant to these Official Rules. In addition to any other requirements set forth in these Official Rules, in order to be deemed eligible for participation, each Video Entry and/or the Entrant submitting it must meet the following conditions and restrictions: if any individual appearing in the Video Entry is deemed to be a minor in the jurisdiction in which he or she resides, such minor’s parent or legal guardian must consent to the use of the Video Entry in this Contest, prior to the Entrant submitting the Video Entry. The Video Entry must not defame or invade the publicity or privacy rights of any person, living or deceased, or otherwise infringe upon any person’s personal or proprietary rights. The Entrant should own or otherwise have the right to submit the Video Entry as contemplated hereunder. The Entry Video must not contain any content that is sexually explicit, sexually suggestive, offensive, illegal, pornographic or obscene or that is in bad taste or is otherwise objectionable to Sponsor, as determined by Sponsor in its sole and absolute discretion. The Video Entry must not contain any commercial or advertising content or any third party trademarks, names or logos other than those of the Sponsor.

CONTEST ENTRY PERIOD: Entry submission for the “Get Married Dream Honeymoon Video Contest” Contest starts at 12:01 a.m. (ET) on April 18, 2008, and ends at 11:59 p.m. (ET) on May 26, 2008 (the “**Contest Entry Period**” or “**Entry Period**”), for both Online Entries and Mail-In Entries. Any Entry that is not received during the Contest Entry

Period will be deemed ineligible for consideration as a possible Grand Prize winner. Sponsor reserves the sole and absolute right to determine the eligibility and non-eligibility of all Entries.

WINNER SELECTION: One (1) potential Grand Prize winner will be selected. From the eligible Entries received by Sponsor during the Contest Entry Period, Sponsor, or its designees, will select, certain Entries that Sponsor, in its sole and absolute discretion, deems as potential Finalists for possible selection as a Grand Prize winner. The number and designation of Finalists will be solely determined by Sponsor in its sole and absolute discretion. In selecting the Finalists, special consideration will be placed on the persuasiveness and creativity of the Video Entries. By entering the Contest, Entrants and Eligible Couples acknowledge and agree that the determination of Finalists by Sponsor will be deemed final and not subject to challenge. The Video Entry submitted by each of the Finalists will appear on the Get Married Website along with any other information that the Sponsor, in its sole and absolute discretion, elects to provide in connection with the Finalists or their respective Video Entry. Registered Members will vote on the Get Married Website for the Video Entry that they deem most worthy of winning the Contest during an online voting period starting at 12:01 a.m. (ET) on June 2, 2008, and ending 11:59 p.m. (ET) on June 9, 2008 (the “**Online Voting Period**”). The Get Married Website database clock will be the official timekeeper for all purposes of this Contest. Subject to the terms contained in these Official Rules, the Entry receiving the highest number of votes from Registered Members during the Online Voting Period will be deemed the winning Entry, with the Eligible Couple designated in the Video Entry being deemed the Grand Prize winner. The Entrant and the Eligible Couple, if different, selected as the potential Grand Prize winner will promptly be notified by e-mail, overnight delivery service and or telephone of the Entry’s selection as potential Grand Prize winner. The Eligible Couple designated as the potential Grand Prize winner will be required to execute and return a notarized Affidavit of Eligibility/Release of Liability and (except where prohibited) Publicity Release form and a completed IRS W-9 form within three (3) business days of date of issuance. A pre-paid overnight delivery service air bill will be provided to facilitate the return of all required documents. Potential Grand Prize winner’s failure to return all required forms in this three (3) day time period may result in the potential Grand Prize winner being disqualified and an alternate winner may be selected at Sponsor’s sole and absolute discretion. If any prize notification or prize is returned as undeliverable for any reason, Sponsor may decide, in its sole and absolute discretion, to select an alternate Finalist as the winning Entry, with the Grand Prize being awarded to the Eligible Couple designated in such alternate Entry, subject, however, to full compliance with all of the terms and conditions of these Official Rules. All federal, state and local tax liabilities, if any, are the responsibility of the Grand Prize winner. Acceptance of the Grand Prize constitutes permission (except where prohibited) by the Entrant, and the Eligible Couple selected as the potential Grand Prize winner for Sponsor to use their name, likeness, picture, voice, biographical information and statements for publicity, advertising, trade and promotional purposes in any and all media and manner and by any and all means now known or hereafter devised in perpetuity worldwide without additional compensation or limitation of any kind, and without the need to get any further consent.

GRAND PRIZE: One (1) Get Married Dream Honeymoon Video Grand Prize will be awarded to the Eligible Couple selected as the Grand Prize winner in accordance with these Official Rules. No other prizes will be awarded, whether to the Entrant or any other party whatsoever. The Grand Prize shall be as follows: a seven (7) day / six (6) night trip

for two (2) to the *Walt Disney World*® Resort in Florida ("**Trip**"), consisting of the following elements: [1] hotel accommodations for one (1) standard room for five (5) nights at a Disney Deluxe Resort to be selected at the sole discretion of Disney Destinations; [2] a one (1) night stay in the Cinderella Castle Suite on the evening of September 18, 2008, only; [3] two (2) 7 day *Magic Your Way* passes; [4] if winner resides more than two hundred fifty (250) miles from the *Walt Disney World*® Resort (the "**Resort**"), round-trip coach air transportation for two (2) persons between the US gateway airport nearest winner's residence ("**airport of origin**") and the Orlando International Airport; [5] if winner resides more than two hundred fifty (250) miles from the Resort, round-trip ground transportation for two (2) persons via limousine between the Orlando International Airport and the Resort; and [6] one (1) \$500.00 Disney Gift Card. All expenses not specifically mentioned herein are not included and are solely the winner's responsibility, including but not limited to: transportation to the Resort if a winner resides less than two hundred fifty (250) miles from the Resort, round trip transportation between the winner's residence and any airport of origin, room service, parking fees, laundry service, food, alcoholic beverages, merchandise, souvenirs, telephone calls, tips, gratuities, service charges, or taxes. Airline carrier and Resort regulations and conditions apply. Travel and lodging are subject to availability, certain restrictions, blackout dates and Sponsor's approval. Trip must be taken between September 13, 2008, and September 24, 2008, with the Cinderella Castle Suite being only available for the evening of September 18, 2008. Approximate retail value: \$4,402.00 that will vary depending upon point of departure and seasonal fluctuation of hotel rates and airfares. Prize is not redeemable for cash or transferable, except to a surviving spouse residing in the same household. No substitution allowed, except, at Sponsor's sole discretion, a prize of equal or greater value may be substituted.

OFFICIAL RULES: The Contest is subject to the Official Rules, and by entering, Entrant agrees to be bound by them.

PRIVACY: All information collected by Sponsor in connection with the Entries will be subject to Sponsor's Privacy Policy available at www.getmarried.com.

GRANT OF RIGHTS; WARRANTIES AND REPRESENTATIONS: As a condition of participation in this Contest, each Entrant hereby grants and agrees to grant to Sponsor and its affiliates the non-exclusive right and license to reproduce, modify, use, post, publish, perform, display, and otherwise distribute online on the Get Married Website or elsewhere, and or otherwise use or exploit in connection with the promotion, publicity and/or advertising of the Contest and/or the Sponsor, each Video Entry (including, without limitation, the likenesses of the Entrant, the Eligible Couple, and any other individuals appearing in the Video Entry) submitted by the Entrant as part of his/her Entry. Each Entrant represents and warrants that with respect to the Video Entry submitted by him/her for purposes of the Contest, the Entrant has, prior to submitting such Video Entry, obtained all necessary rights (including, as applicable, copyright, moral rights, publicity and privacy rights), licenses, consents and authorizations from the Eligible Couple and any other individual appearing in the Video Entry (and/or such other Individual's parent or legal guardian if the other individual is a minor) and from the person (if that person is an individual other than the Entrant or an other individual appearing in the Video Entry) who shot the Video Entry, to allow Entrant to grant the

rights granted by Entrant pursuant to these Official Rules and to allow Sponsor's and/or its affiliates' free and unrestricted exercise of such rights as provided hereunder.

RELEASE OF LIABILITY/GENERAL CONDITIONS: Contest Entities shall not be responsible or liable for any Entries that are entered by other than human means (such as by an automated computer program or any non-human mechanism, entity, or device), in excess of the stated limit, or for Entries that are late, forged, destroyed, lost, misplaced, stolen, misdirected, tampered with, incomplete, deleted, damaged, garbled, or otherwise not in compliance with these Official Rules, and all such Entries will be disqualified. By entering the Contest, each Entrant agrees: (i) to be bound by these Official Rules and by all applicable laws and decisions of Sponsor which decisions shall be binding and final; (ii) to waive any rights to claim ambiguity with respect to these Official Rules; (iii) to waive all of his/her rights to bring any claim, action, or proceeding against any of the Contest Entities in connection with the Contest, and/or the use, misuse or decision not to use any Entry or any description provided hereunder; and (iv) to release, indemnify, and hold harmless each of the Contest Entities and their respective officers, directors, employees, agents, shareholders and representatives (collectively the "**Releasees**"), from any liability (including, but not limited to, liability for defamation, libel, slander, invasion of privacy, infringement of publicity or any intellectual property rights, any property loss, damage, personal injury, bodily injury, death, expense, accident, delay, inconvenience or irregularity), costs and expenses (including, without limitation, attorney's fees) that may arise in connection with: (a) the Entrant's, the Eligible Couple's, or any other individual's participation or inability to participate in the Contest, (b) the use, misuse, or non-use of an Entry, and/or the violation of any third party privacy, personal, publicity or proprietary rights, (c) typographical errors in these Official Rules or any Contest promotional materials, (d) acceptance, possession, defects in, use, misuse or inability to use the Grand Prize (or any component thereof), (e) any change in the prizing (or any components thereof) due to unavailability, creative considerations, or due to reasons beyond Sponsor's control, including but not limited to by reason of any acts of God, any action(s), regulation(s), order(s) or request(s) by any governmental or quasi-governmental entity (whether or not such action(s), regulation(s), order(s) or request(s) prove(s) to be invalid), equipment failure, threatened or actual terrorist acts, earthquake, war, fire, flood, explosion, unusually severe weather, hurricane, embargo, labor dispute or strike (whether legal or illegal), labor or material shortage, transportation interruption of any kind, work slow-down, civil disturbance, insurrection, riot, or any other cause beyond any of the Contest Entities' control, or as otherwise permitted in these Official Rules, (f) any interruptions in or postponement, cancellation, or modification of the Contest, (g) human error, (h) incorrect or inaccurate transcription, receipt or transmission of any part of an Entry (including, without limitation, the Entry information or any parts thereof), (i) any technical malfunctions or unavailability of the Get Married Website or any telephone network, computer online system, computer timing and/or dating mechanism, computer equipment, software, or Internet service provider, or mail or delivery service utilized by any of the Contest Entities or by an Entrant, (j) interruption or inability to access the Contest, the Get Married Website or any other Contest-related web pages, or any online service via the Internet due to hardware or software compatibility problems, (k) any damage to Entrant's (or any third person's) computer and/or its contents related to or resulting from any part of the Contest, (l) any lost/delayed data transmissions, omissions, interruptions, defects, and/or any other errors or malfunctions, (m) any late, lost, stolen, mutilated, misdirected, or postage due Mail-In Entries, (n) any wrongful, negligent, or unauthorized act or omission on the part of any of the Contest Entities, or any of their agents or employees, (o)

cancellations, delays, diversions or substitutions or any act or omissions whatsoever by the air carrier(s), or other transportation companies, hotel(s), or any other persons providing any of these services and accommodations to passengers including any results thereof such as changes in services or accommodations necessitated by same, or (p) loss or damage to baggage. The Grand Prize winner hereby acknowledges that the Contest Entities have neither made nor are in any manner responsible or liable for any express or implied warranty, representation or guarantee, express or implied, in fact or in law, relative to the Grand Prize or any component thereof. Proof of entering information at the Get Married Website, uploading an Entry or mailing an Entry is not considered proof of delivery or receipt. Illegible, incomplete, mechanically reproduced and Entries in excess of the number stated above from any one (1) valid e-mail address, person and/or household address will be disqualified. All Entries become the property of Sponsor and will not be acknowledged or returned. False, fraudulent or deceptive Entries or acts shall render entrants ineligible. If for any reason the Contest is not capable of running as planned, or if the Contest or the Get Married Website (or any portion thereof) becomes corrupted or does not allow the proper playing of the Contest and processing of Online Entries or Mail-In entries in accordance with these Official Rules, or if infection by computer virus, bugs, tampering, unauthorized intervention, actions by Entrants, fraud, technical failures, or any other causes, in the Sponsor's sole opinion, corrupts or affects the administration, security, fairness, integrity, or proper conduct of the Contest or the granting of the Grand Prize or any component thereof, Sponsor reserves the right, in its sole discretion, to disqualify any individual implicated in such action and/or to cancel, terminate, modify, or suspend the Contest or any portion thereof. In the event the Contest is cancelled, and to the extent possible as determined by Sponsor, Sponsor will select a new Entrant from among all eligible, non-suspect Entries received prior to the time of the action or event warranting such cancellation, and to award the Grand Prize to the Eligible Couple designated in such selected Entry.. In the event that Sponsor determines that there are no eligible Entrants, Sponsor reserves the right in its sole discretion to not award the Grand Prize (or any portion thereof). **ANY ATTEMPT BY AN ENTRANT OR ANY OTHER INDIVIDUAL TO DELIBERATELY DAMAGE ANY WEB SITE (INCLUDING, WITHOUT LIMITATION, THE GET MARRIED WEBSITE) OR UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST IS A VIOLATION OF CRIMINAL AND/OR CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES AND OTHER REMEDIES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.** If a dispute arises about who submitted an Online Entry on the Get Married Website, the Online Entry will be deemed submitted by the authorized account holder of the e-mail account entered. The authorized account holder is deemed the natural person who is assigned to an e-mail address by an Internet access provider, service provider, or other online organization that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. The Entrant submitting the winning Entry and the Eligible Couple designated in such Entry may be requested to verify that they are the authorized account holders of the e-mail addresses submitted in connection with the winning Online Entry (if applicable) and that all other eligibility requirements are otherwise satisfied.

ARBITRATION: BY ENTERING INTO THE CONTEST, EACH ENTRANT AND ELIGIBLE COUPLE AGREES THAT ANY CONTROVERSY OR CLAIM ARISING OUT OF OR RELATING TO THIS CONTEST (EXCLUDING ANY CONTROVERSY OR CLAIM ARISING OUT OF OR RELATING TO THE TRIP OR THE USE THEREOF) OR RELATING TO THESE OFFICIAL RULES, THEIR ENFORCEMENT, ARBITRABILITY

OR INTERPRETATION, SHALL BE SUBMITTED TO FINAL AND BINDING ARBITRATION, TO BE HELD IN ATLANTA, GEORGIA, BEFORE A SINGLE ARBITRATOR. THE ARBITRATOR SHALL BE SELECTED BY MUTUAL AGREEMENT OF THE PARTIES OR, IF THE PARTIES CANNOT AGREE, THEN BY SELECTING AN ARBITRATOR FROM A LIST OF ARBITRATORS SUPPLIED BY JAMS (JUDICIAL ARBITRATION AND MEDIATION SERVICES). IF THE PARTIES STILL CANNOT AGREE ON AN ARBITRATOR, THE ARBITRATOR SHALL BE APPOINTED BY JAMS. THE ARBITRATION SHALL BE A CONFIDENTIAL PROCEEDING, CLOSED TO THE GENERAL PUBLIC. THE ARBITRATOR SHALL ISSUE A WRITTEN OPINION STATING THE ESSENTIAL FINDINGS AND CONCLUSIONS UPON WHICH THE ARBITRATOR'S AWARD IS BASED. THE PARTIES WILL SHARE EQUALLY IN PAYMENT OF THE ARBITRATOR'S FEES AND ARBITRATION EXPENSES AND ANY OTHER COSTS UNIQUE TO THE ARBITRATION HEARING (RECOGNIZING THAT EACH SIDE BEARS ITS OWN DEPOSITION, WITNESS, EXPERT AND ATTORNEYS' FEES AND OTHER EXPENSES TO THE SAME EXTENT AS IF THE MATTER WERE BEING HEARD IN COURT). NOTWITHSTANDING THE FOREGOING, THE ARBITRATOR MAY REQUIRE THAT SUCH FEES BE BORNE IN SUCH OTHER MANNER AS THE ARBITRATOR DETERMINES IS REQUIRED IN ORDER FOR THIS ARBITRATION CLAUSE TO BE ENFORCEABLE UNDER APPLICABLE LAW.

GOVERNING LAW: Each Entrant acknowledges that the internal substantive laws (as distinguished from the choice of law rules) of the State of Georgia and the United States of America applicable to contracts made and performed entirely in Georgia shall govern the validity and interpretation of these Official Rules.

NO INJUNCTIVE RELIEF: EACH ENTRANT AND ELIGIBLE COUPLE UNDERSTANDS AND AGREES THAT THEY SHALL HAVE NO RIGHT TO ENJOIN OR RESTRAIN THE DEVELOPMENT, PRODUCTION, ADVERTISING, PROMOTION, DISTRIBUTION OR EXPLOITATION OF THE CONTEST, OR ANY OTHER PRODUCTION OR PROJECT OF SPONSOR OR ANY OF ITS AFFILIATES.

OFFICIAL GRAND PRIZE WINNER /OFFICIAL RULES: The Grand Prize winner will be posted on the Get Married Website after selection and verification. These Official Rules will likewise be posted on the Get Married Website.
